Dr. █████ was very helpful; however, he was not here when the event happened. I did not feel confident enough or safe enough to report the incident originally as the first authority figure I talked to told the assaulter about our meeting before it happened. The authority figure told me this. I did not pursue action until the next year.

I deeply appreciate the clear instructions and timeliness given for reporting incidents, as well as the intentionality and gentleness that Dr. [REDACTED] approached student with.

After the program director reported it, no further action was taken by the University. It would have been nice if the Title IX coordinator at least checked in.
